| 3. | Ways to Meet RPO | The quantum of electricity generated by the consumer of the Rooftop Solar PV System under the net metering arrangement, shall if such consumer is not an obligated Entity, Qualify towards the Solar RPPO of the Distribution Licensee. | | | |
| 4. | Metering | <ol style="list-style-type: none"> 1. The purchase made from solar roof-top projects (gross-metering), the unutilized banked energy deemed to have been purchase by the Distribution Licensees from renewable energy projects under open access regulations, purchase made at mutually agreed prices and all such other transactions for which the generator(s) does not claim RECs shall not be treated as fulfillment of the RPPO. 2. The Distribution Licensees shall compulsorily procure 100% power produced from all the Waste-to Energy plants in the state. 3. The Distribution Licensee's RPPO shall include RESCO for the purpose of this Regulation. | | | |
| 5. | Certificates | The procurement, by the obligated entity(s) issued under the CERC Regulation, 2010, as amended from time to time shall be subject to such directions as the commission may issue from time to time. | | | |
| 6. | Obligated Entity | Distribution licensee , Captive Users and Open Access Consumer | | | |
| 7. | State Agency | The State Agency shall function in accordance with the directions issued by the Commission and shall act in accordance with the procedures / rules laid down by Central Agency for discharge of its functions under the CERC regulation, 2010 as amended from time to time. | | | |
| 8. | Remuneration and Charges | The Commission may time to time based on the proposal in this regard from the State Agency fix the remuneration and charges payable to the State Agency for discharge of its functions under these Regulations. | | | |
| 9. | Eligibility | The eligibility and registration of certificates shall be governed by the CERC Regulations, 2010as amended from time to time. | | | |
| 10. | Consequences of Default | <p>If the obligated entity does not fulfill the RPPO of this Regulation during any year, the Commission may direct the obligated entity to deposit a separate fund, to be created and maintained by the State Agency, such amount on the basis of the shortfall in units of the RPPO and the Forbearance Price decided by the Central Commission.</p> <p>The fund so created shall be utilized in the manner as may be specified by the Commission either through general or special order.</p> | | | |
