2.	Applicability	The scheme to be applicable to the Rooftop Solar Power Generators set up and commissioned during the operative period of Solar Power Policy-2015.
		Parameters and terms-conditions of Solar Power Policy-2015 to be applicable.
		<ul> <li>Scheme limited for Household Rooftop Projects only. Any Industrial, Commercial and other consumers or Government and Semi-Government Organizations not eligible for this subsidy.</li> </ul>
		<ul> <li>Rooftop Solar Plants registered under Solar Power Policy-2015, prior to introduction of the scheme, also eligible for the benefit of the scheme, provided they satisfy other parameters of the scheme and Solar Power Policy-2015</li> </ul>
3.	Resolution & Benefits	<ul> <li>Scheme limited to installation of 2 kW Rooftop Solar system only. The capacity of the Plant might be higher subject to a ceiling of 50% of contracted load. However, per consumer, maximum Subsidy available shall be Rs. 20,000.</li> </ul>
		<ul> <li>The initial target to be first 1,00,000 consumers. Thereafter, based on the review and as decided by the Government, this scheme may be continued, discontinued or modified.</li> </ul>
		<ul> <li>As per the terms prescribed in the Solar Power Policy-2015, the Consumer to install only new plant &amp; machinery and should not shift the plant elsewhere and should be a consumer of the local DisCom and the premises where the rooftop system is based should be connected to the local DisCom's Grid System.</li> </ul>
		<ul> <li>Beneficiary to own the rooftop solar system, and be in legal possession of the premises including rooftop and terrace on which the plant is installed;</li> </ul>
		<ul> <li>Benefit would be in addition to any benefits that the applicant might get from the Central Government.</li> </ul>
		<ul> <li>Applicant not allowed to get any other benefit from any other scheme of the State Government for the same investment, and if found otherwise the amount of subsidy to be recovered forthwith.</li> </ul>
4.	Nodal Agency	Gujarat Energy Development Agency (GEDA) to act as the Nodal Agency
		<ul> <li>GEDA and Distribution Company to jointly certify about successful installation and commissioning of the system</li> </ul>
		<ul> <li>There after GEDA to release subsidy to the applicants, limited to Rs. 20000/- per consumer.</li> </ul>
5.	Implementation of Scheme	Implementation of this Scheme to be done under the administrative control of the Climate Change Department in consultation with Energy & Petrochemicals Department.
